Section 5 - Firearms Act 1968 Declaration:

Firearms Act 1968 – Section 21

Under the terms of the new Home Office approval criteria and conditions for shooting clubs, ALL club members, ALL prospective members and ALL guests must sign a declaration that they are not prohibited from possessing a firearm or ammunition by virtue of Section 21 of the Firearms Act 1968.

Section 21 applied to anybody who has been sentenced to imprisonment or Youth Custody or detention in a Young Offender Institution, for three months or more.

The period for which they are prohibited depends on their length of sentence. If the sentence was longer than three years is for life. If the sentence was three months or more, but less than three years, the prohibition lasts for five years from the date of their release.

It is a legal offence for someone who is prohibited by Section 21 to have a firearm or ammunition in their possession at any time. It is also a legal offence for a person to transfer, let on hire, give or lend a firearm or ammunition to someone they know or has reasonable grounds to be prohibited by Section 21.

Section 6 - Data Protection Act Notice:
